AGENDA OF BILATERAL WORK PLAN FOR DRILLS AND PROTOCOLS OF RESPONSE IN THE REGIONAL EMERGENCY OF EARTHQUAKE AND TSUNAMI



Objectives of the agreement

1. Jointly prepare an action plan, setting out short, medium and long term.
2. Conduct training together in the area of methodological cycle for risk management, prevention and phase of recovery.
3. Conduct drills together in Tacna, Arica and Parinacota, in order to measure the responsiveness of the population and local authorities, promoting a culture of prevention and self-care in the community, preparing to emergencies such as earthquakes and tsunamis.

Objectives of the agreement



4. Exchange information on seismic hazard materials and perform together scientific and technological research to diagnose the potential vulnerabilities of the population from emergencies, disasters and catastrophes, in order to prevent the consequences.
5. Hold regular meetings between institutions in order to update your contacts and testing telecommunications systems, so to maintain a channel of communication between the two institutions.
6. Establish appropriate channels and mechanisms for the delivery of humanitarian aid, in the first attention, in an emergency, disaster or catastrophe occurring in both Tacna and Arica-Parinacota.

Progress on the agenda of activities.



□ Prevention, preparedness and response binational Peru-Chile.

A meeting was held on June 9, 2010 in Arica involving INDECI ONEMI to present progress on identifying projects in border cities, noting that the city of Arica has soils vulnerability studies and seismic microzonation.

□ Joint training for search and rescue brigade between Tacna and Arica:

The Fire Department of Tacna already has a training polygon search and rescue actions in collapsed structures, opened April 2010, to train search and rescue brigades, remain available to both cities for the joint formation of groups search. It also has scheduled a course BREC for both cities.

❑ **The Line of cooperation for the establishment of a Fire Training Academy in Peru and Chile.**

Scheduled a meeting to share knowledge in this area for the month of July 2011. Still pending the outcome of the meeting.

❑ **Proposed Settlement of cooperation and mutual assistance in customs and immigration disaster**

Coordinated the workshop for the first week of July 2011, involving SUNAT, Santa Rosa's control and Chacalluta's control. Pending.

❑ **Operating Plan mutual joint organized response to disasters, with emphasis on communications.**

Drills for permanent communication between the Fire Department of Tacna and Arica.

❑ **Joint exercises for emergency drills and sharing common experiences.**

✓ In June 2011, INDECI participated as an observer of exercise of the Earthquake and Tsunami in Arica .

✓ In October this year will be held the joint exercise in Tacna and Arica.
